1. Increased productivity

You and your employees can work anywhere, anytime, with documents and business information at your fingertips.

2. Reduction in admin expense

By saving paperwork to the cloud, you reduce physical files and storage, in turn saving administration costs.

3. Save on IT costs

Smartphones are now powerful computing devices and, for some, could even replace the need for laptops, tablets or desktop computers.

By using apps that connect to your business systems, you can keep employees accountable, and check on operations and performance in real time.

Think beyond phone calls, messaging and email. Here's 11 ways to do business on your mobile, which might surprise you:

- 1. Manage timesheets and track employee hours using a timesheet app.
- 2. Allocate tasks to staff or contractors. and monitor performance.
- 3. Access and review business and company data, such as real time sales information.
- 4. Check stock levels and place orders from suppliers.
- 5. Create, edit and proofread documents and spreadsheets.
- 6. Send out agreements for signature, including sales contracts. employment offers, loan documents and compliance checks.

- 7. Record and keep track of notes by storing them in one place that can be accessed from anv device.
- 8. Manage your business' social media accounts, including posting new content and community moderation.
- 9. Update your customer relationship management (CRM) system right after meeting with a customer or prospect.
- 10. Scan and store your receipts using a receipt management app, making it easier to complete expense and tax deduction reports.
- 11. Send and manage invoices.

EXAMPLES OF MOBILE APPS

Saving business files and data to the cloud makes it possible to access that information from any internet-connected smartphone or device.




By using apps downloaded to your smartphone, it's easy to connect with your company information and systems, as well as access files and do business.

There are specialised apps that allow you to manage certain processes from your mobile. Here are some examples:

- Accounting apps like Xero and MYOB enable you to produce and send invoices instantly.
- Expensify allows you to easily track your receipts and manage employee expenses on the go.
- DocuSign's eSignature app gives people a convenient way to sign, complete and request signatures anytime, anywhere, from any device.

Then there's an assortment of other basic smartphone apps that enable you to be more productive on the go. For example:

- Notes or lists recorded in Evernote or Wunderlist can be accessed on your phone, desktop and laptop.
- Google's G Suite or Microsoft Office apps allow you to use all the desktopfamiliar software on your mobile.
- Adding the Google Drive or Microsoft OneDrive app to your phone will provide you 24/7 access to all your files.
- A messaging app, such as Skype or Slack, encourages collaboration between employees.



In the past, getting a signature on an important agreement with a customer or supplier has been tedious and frustrating.





How to get a signature fast, via mobile

- 1. Log in to your DocuSign mobile app and tap the yellow + icon.
- 2. Tap the blue + icon to add a document.
- 3. Tap the source for the document, then select the document.
- 4. Tap ADD A SIGNER.
- 5. Tap the blue + icon and enter the full name and email address of the recipient. To automatically add yourself, hit ADD ME.
- 6. Select the role of the recipient. When finished, hit OK, then tap the check mark in the upper right of the screen.
- 7. Enter a message if desired, then tap NEXT.
- 8. Add any required fields to the document. When finished, tap SEND.

"Our value proposition lies in the customer experience. Our customers are generally time-poor and can do without the hassle of coming in to sign documents, or printing and scanning them from home," Hector says.

Harris Real Estate is using DocuSign integrated with REI Forms LIVE to complete and send contracts without needing a physical, printed copy. This can be done on the road, from a mobile device.

The move has "fundamentally improved" the way the firm prepares, signs and manages agreements, and that's made the process much easier for customers, says Hector.

Customers can sign contracts electronically from any device and most do it immediately.

That's a "game changer" for agents, he says. "We have much more time to spend with customers and it's helping us easily go from 180 to 300 sales a year."

Hector says this way of doing business is giving rise to the mobile agent.
